This week in Annapolis nearly 100 farmers from across the state participated in Farm Bureau Day in Annapolis. The morning event on Wednesday featured briefings on issues and breakfast with 60 legislators. We would like to thank all of the farmers who met with legislators over breakfast and in their offices on our priority issues. Several dozen farmers stayed to listen to the Governor's State of the State address before heading home. Finally, we'd like to thank the many legislators on both sides of the aisle who took time to attend our event.

The bills scheduled for hearing next week include:

Tuesday, February 5, 2019

SB0099 - Anne Arundel County - Public Safety - Buildings Used for Agritourism

Senator Elfreth, EHEA, at 1:00pm in 2 West Miller

This bill adds Anne Arundel County to the list of counties that exempt existing Ag structures that are going to be used for Agritourism from being required to retrofit the structure with bathrooms, sprinklers and other high occupancy requirements. This exemption allows up to 200 people in the structure. The structure must still adhere to the structural integrity standards as well as entrance & exit requirements. The counties already exempt are: Carroll County, Cecil County, Garrett County, and Howard County.

Maryland Farm Bureau policy defines Agritourism as activities conducted on a farm and offered to the public or to invited groups for the purpose of education, recreation, or active involvement in the farm operation. Directly related to this bill, MFB policy reads: We further support the inclusion of specific language in the building code to permit public access to existing, structurally sound, nonresidential buildings without mandated upgrades to the full current codes.

MARYLAND FARM BUREAU SUPPORTS SB 99

HB0050 - Department of Agriculture - Maryland Produce Safety Program

Chair of Environment and Transportation Committee on Behalf of Maryland Department of Agriculture, E&T at 1:00pm in 250 HOB

This legislation would establish the Maryland Produce Safety Program in the Department of Agriculture and give the Secretary of Agriculture the authority to conduct inspection, compliance and enforcement activities for the Produce Safety Rule instead of FDA. As MDA is familiar with Maryland farmers, agricultural practices, agricultural water sources, nutrient management and other relevant state regulations, we are better equipped to assist farmers with compliance while taking into account other state regulations. The legislation does not contain any provisions that would place an additional burden on Maryland farmers.
