Welcome to the first *Hotline* of the 2019 Maryland General Assembly session. The *Hotline* will be sent to you each week during the session to make you aware of upcoming hearings for bills that will impact Maryland's farm community. We will ask Farm Bureau members to "take action" on proposed legislation to ensure the preservation and protection of Maryland agriculture. The *Hotline* is distributed to more than 6,000 farmers across the state and to all 188 members of the Maryland General Assembly.

SB0025 - Real Property - Conservation Easements, Covenants, Restrictions, and Conditions - Recording Notice

Chair of Judicial Proceedings Committee on Behalf of the Administration, JPR at 1:00pm in 2 East Miller

This bill authorizes the Maryland Agricultural Land Preservation Foundation, the Maryland Historical Trust, the Maryland Environmental Trust, and the Department of Natural Resources to record notice of easements, covenants, restrictions, and conditions in the land records of the county in which the property interest is located.

As conservation easements become older and older on properties, there are times when real property searches miss these easements when a prospective buyer is looking to purchase the property where the easement is located. This bill would allow the agencies to add these easements to the land records so these easements will be noticed at the time of property searches.

MARYLAND FARM BUREAU SUPPORTS SB 25

SB0056 - Secretary of Agriculture - Regulation of Poultry to Protect Animal Health and Control Avian Influenza

This Maryland Department of Agriculture (MDA) bill further defines and clarifies a live poultry market and a poultry dealer in Maryland. The bill adds to the definition of live poultry market as a facility **or a location** where poultry is slaughtered & sold on-site **and is offered for sale, sold, distributed or transferred**. It also amends the definition of a poultry dealer to a person that engages in the business of buying, selling, exchanging, or transporting poultry. This language is being added to ensure MDA has the ability to properly implement an animal health protection program for poultry in the state. This will help ensure all types of poultry operations are included to make sure poultry farms large and small are properly protected from potential disease outbreaks such as Avian Influenza.

MARYLAND FARM BUREAU SUPPORTS SB 56

SB0057 - Agriculture - County Agricultural Land Preservation Programs

This Maryland Department of Agriculture (MDA) bill is to clarify language in the Agriculture article that was enacted with HB 620 during the 2018 legislative session, but was only included in the Land Use article. HB 620 that was enacted into law last year had two parts. First it extends the timeframe for when a county Ag land preservation program is required to recertify its program with the State from every 3 years to every 5 years. Part two of the bill extends the time that a county program can retain its unused land preservation funds from 3 years to 6 years. This is very helpful since MALPF has used an every other year easement acquisition protocol for several years now. Under current law, the county has to send back any unused funds every 3 years. Because of every other year acquisition cycle, this could result in counties sending back significant amounts of fund just because the state didn't have an acquisition cycle that third year. This extension would allow a county to more effectively use their allocated land preservation funds and preserve more farmland in their county. Since this bill is just enacting the same language we supported in 2018, we support this as well.

MARYLAND FARM BUREAU SUPPORTS SB 57

SB0058 - Maryland Agricultural Land Preservation Foundation - Elimination of District Agreements

Chair of Education, Health, and Environmental Affairs Committee on Behalf of Maryland Department of Agriculture, EHEA at 4:00pm in 2 West Miller

This Maryland Department of Agriculture (MDA) bill just deletes obsolete references to district agreements within the Maryland Agricultural Land Preservation Foundation program and codifies the elimination of these district agreements and the continuation of agricultural land preservation districts in which an easement has been transferred to the Foundation and districts which provide a property tax credit to a landowner. Since this is just clean-up language and no Ag land owner is going to be removed from participating in the MALPF easement program or would have to pay higher taxes, Maryland Farm Bureau supports this bill.

In Other Ag News

Some FSA Offices Open on Thursday, Friday and Monday

The Agriculture Department has announced a limited opening of a select number of county Farm Service Agency offices for three days only for limited services related to select farm operating and farm ownership loans, and to work on processing 1099s related to these loans. The dates are Thursday and Friday (Jan. 17-18) and Tuesday, Jan. 22. In Maryland, offices will be open in Frederick and Denton only.

2018 Annual Implementation Reporting Forms to Be Mailed, Available Online

The Maryland Department of Agriculture has announced that the 2018 Annual Implementation Reporting Forms and instructions will be mailed in early January to approximately 5,500 Maryland farmers who are regulated under the department's Nutrient Management Program. These farmers are required to follow nutrient management plans when fertilizing crops and managing animal manure. The forms are due March 1 and will be used to fully account for everything that Maryland farmers are doing to protect water quality in the Chesapeake Bay watershed and its tributaries.
