Farmers Win Big in Annapolis this Session!

Maryland Farm Bureau's Government Relations team worked hard this session to make sure Maryland's agricultural voice was heard. We closely watched 195 bills and submitted testimony in either support or opposition on 72 of them. Of the 52 bills Maryland Farm Bureau supported, 29 passed out of both chambers and await the Governor's signature in the next few weeks. **Some of our priority bills that passed were:**

- The creation of a 6-month 88,000-pound live poultry hauling permit to help chicken growers on the Eastern Shore move poultry more efficiently and less costly during the winter months throughout Delmarva. Sponsored by Sen. Mathias and Del. Otto.
- The reauthorization of the 88,000-pound milk hauling permit during the spring flush. Sponsored by Sen. Norman and Del. Jacobs.
- A Deer Crop Damage Permit corrective bill to insure Maryland farmers can continue to address problem deer year-round (including Sundays). Sponsored by the Eastern Shore Delegation.
- A Landowner Liability Exemption when leasing ground to hunters. Sponsored by Del. Gerald Clark.
- A Beehive protection bill to allow a registered bee owner to remove problem bear when they damage beehives. Sponsored by Del. McKay.
- Movement of the Seafood and Aquaculture Marketing from DNR to MDA. Requested by MDA.

In addition to bills we supported, there were 18 bills we opposed that could have negatively affected Maryland agriculture. MFB staff and several county Farm Bureau members worked hard to either kill or amend to remove the negative effect on farmers.

Some of those priority bills were:

- The Livestock Antibiotics disease prevention ban. MFB, along with a coalition of livestock groups and supporters, amended this bill to conform the disease prevention language to the Federal law that went into effect on January 1, 2017. We also removed the language that would have mandated livestock producers make their private livestock medical records available to the public. *Continued on page 5.*

Food safety and consumer preferences are on my mind this month as spring planting and the ice cream season get underway. Like all farmers, my priority is to create wholesome products for my family and my customers.

Earlier this month I spent two days in Columbus with Nationwide and the leaders of the eight other Farm Bureau sponsor states. We interviewed a panel of consumers about their priorities when selecting food for their families. This was my first experience with a consumer panel. Charlie Arnott from the Center for Food Integrity organized and moderated the event. The five panelists were from the local area. They shop at various grocery stores and farmers' markets. They are all looking for quality food, reasonably priced, that they believe will be good for their families.

I was surprised to learn that none of the five were dogmatic in their food choices. They lean towards food with fewer ingredients. They like "natural" and "fresh" options. But they were not opposed to GMOs or traditionally produced products. They choose organic foods sometimes, when they can afford them. And they all have confidence that their food is safe. In fact, when we asked about food safety, they discussed the impact on their long-term health.

When we asked about restaurants that have had foodborne illnesses, they said they avoided the vendors for a short time. But they believe the companies "owned" the issue and made changes to prevent a reoccurrence. They have confidence that our regulatory system works.

We also had the opportunity to hear from Jeni Britton Bauer, founder of Jeni's Splendid Ice Creams. Her story is especially meaningful to me. She has had great success with her high quality, specialized flavors. She was an art student who took her creativity to the food world. She likes to build unique textures, scents and flavors. She went from selling at the local farmers' market, to several retail locations and nationwide retail sales. And in 2015, her business was almost destroyed when a sample tested positive for Listeria.

Her immediate response – ownership, if you will – to the problem is what made the difference between losing the business entirely and re-emerging with a strong, respected company that has retained market share and built a bigger base of loyal customers.

I think all of us in farming share Jeni's commitment to excellence. We want to put forward products that are safe for our customers, our land and environment around us. The new federal regulations under the Food Safety Modernization Act are designed to help us be our best. They won't come easy. And they may still need to be refined. But, I urge you to work with the MD Department of Agriculture and the University of Maryland Extension to learn how to implement the FSMA on your farm.

For our Nationwide farm policy customers, I urge you to take advantage of the FSMA expertise that is offered as a new benefit to your policy. Contact your NW farm agent to arrange a personal review to help implement these new federal rules. I know I will.

At Farm Bureau, we want to do everything we can to maintain the confidence our consumers have in the healthy food network we all provide.

The Future of the Farm



Our attention is pulled in a lot of different directions; and that is especially true in our busy seasons. Finding time to talk to your family about the future of the farm may be difficult. You may also be uncomfortable with the thought of selling your farm or handing over control to family members.

Just as you plan every spring so that your farm can have a successful year; you should consider planning long-term so your farm can be successful for years to come. Developing a solid transition plan for your farming business will help ensure that your family's wishes are met, and emotional stress is minimized.

Here are a few things you should know about transition planning:

- Transition planning is different from estate planning. Estate planning is concentrated on tax liabilities and ways to lessen your tax burden. Succession plans have a broader focus and that is on planning for the future of the farm. Estate planning can be just a piece of a larger succession planning effort.
 - At retirement a farm succession plan can include many things. This can include an arrangement to sell or transfer ownership to a family member, and a plan to liquidate farm assets like equipment, livestock or land at auction. A transition plan may also include other options for your land like renting or leasing.
 - You can plan for your desired result. By concentrating on the desired outcome you can feel comfortable and confident in the plan to achieve that outcome. The proper transition plan puts you in control now of the decisions that may be needed in the future. You can plan for your own retirement by deciding what involvement you'd like to continue to have and what income you may need as your retirement age nears. You can also gain assurance that the needs of your spouse, your children and your farm are considered down the line.
 - An effective transition plan is able to identify the next generation of operator. If you have a family member who could and may want to take over the operation, you should be comfortable that they have the knowledge and skills to run it profitably. If it's being passed down to children, you may ask yourself if they all have an interest in having an active role; and if not, how should they be considered.
 - Getting it right the first time. Succession plans sometimes fail because certain risks were not considered during the planning stages. These can include inadequate cash flow, liquidation of some assets to provide for retirement, poor farm estate planning and unresolved issues between family members or a successor who's not prepared to lead and manage the farm business.
- It's important to enlist the help of qualified professionals who don't have a stake in the final decisions. They can help you make sound, unbiased decisions for your farm estate. Qualified professionals may include your banker, your accountant, your personal attorney or a financial or estate planner who specializes in farm estate planning. MFB Board of Directors Visit Maryland Representatives in D.C.

Maryland Farm Bureau Officers, Board of Directors and staff attended the American Farm Bureau Advocacy Conference from February 27 – March 1, 2017 in Washington, D.C. Board members attended Issue Advisory Committee meetings and our Board meeting on Monday. Advocacy Training & Outlook sessions were held on Tuesday, followed by breakout sessions and the AFBF Political Issues Briefing. EPA Administrator Scott Pruitt also spoke on Tuesday about President Trump pulling the Waters of the United States (WOTUS) Rule that afternoon, which was great news for farmers.

Our Board members and staff visited Maryland representatives on Capitol Hill all day Wednesday to discuss national agricultural issues and policy. We spoke with Sen. Chris Van Hollen, Rep. John Delaney, Sen. Ben Cardin, Congressman Andy Harris and representatives from the offices of Rep. Anthony Brown, Rep. Dutch Ruppersberger, Rep. Jamie Raskin and Rep. Steny Hoyer.

The main issues of conversation included agricultural tax reform, immigration and agriculture labor reform, regulatory reform and the 2018 Farm Bill. Our Board members expressed Farm Bureau's support for:

- fair and equitable tax reform with cash accounting and like-kind exchanges,
- border security with a more flexible and efficient Visa program housed under the USDA,
- a fair, transparent regulatory system that takes economic impacts into account and respects our freedoms, and
- a 2018 Farm Bill that protects the current Farm Bill program spending, includes nutrition and farm programs together and has risk management tools which include both federal crop insurance and commodity programs as top funding priorities.

Maryland Farm Bureau appreciates our Senators and Congressman and their staffers who met with our Board members and continue to support American agriculture. Maryland is happy to have such a strong relationship with our representatives in Washington and look forward to working with them and the Trump administration on agricultural issues in the future.



MFB Young Farmers and WLC Attend AFBF FUSION Conference

MFB Held Farm Labor Visa Workshop

On March 8, Maryland Farm Bureau hosted a workshop to educate our membership about H-2A and H-2B Visas and how to apply for foreign labor using the state's online software. A variety of producers and business owners were in attendance. Merlin Williams from the Maryland Department of Labor, Licensing and Regulation gave a presentation focused on the H-2A Temporary Agricultural Worker program, outlining who can participate, how to participate, wages, getting workers to the farm and how the application process works at the state and federal level.

In the afternoon, he walked participants through the online application step-by-step. The day closed with a question and answer session. Literature providing information on H-2B Visas, American Farm Bureau Federation's stance on immigration reform and a guide to agricultural labor laws from the UMD Agriculture Law Education Initiative were available to workshop participants. This bill would provide college graduates who have owned a farm for 5 years and are still struggling to pay student debt some assistance with their payments.

As I college student, I really liked this bill because although it is hard to balance a farm and college, college helps you learn about the changing ways and things like budgeting and management that you may not have known from experience. Not only will this bill help those who went to school, but it hopefully will help to encourage more farmers to take on college.

This experience was extremely rewarding and educational and I cannot wait to apply what I have learned in the future!



- The Community Healthy Air Act that targeted the Eastern Shore poultry growers died in committee due to a solid showing by our poultry growers and making sure the committee received the correct information on how chickens are grown and air quality inside and out of their poultry houses.
- The Atrazine Study bill was killed in committee again due to a strong showing from our Farm Bureau members and a coalition between the Maryland Grain Producers and MFB to detail the thousands of studies that have already been done since it was first approved in 1959.
- The State-Owned Property Pollinator Habitat Plan ban on the use of Neonicotinoids bill. MFB worked with the bill sponsors and committees to amend the bill to make sure farmers and their workers were exempt from the restrictions.

As you can see, Maryland Agriculture had a great year. MFB staff wants to thank all of our members who testified, called or emailed legislators on bills this session. We also want to thank the Members of the Maryland General Assembly for making sure Maryland's largest industry was heard and protected. Please make sure to thank your Delegates and Senators for their support this year!

Maryland Farm Bureau Gives Back to AFBF Foundation & Wildfire Relief Funds

In honor of National Agriculture Day on March 21, the Maryland Farm Bureau Board of Directors voted to make contributions to the American Farm Bureau Foundation for Agriculture (AFBFA) and to Kansas, Oklahoma and Texas Farm Bureaus for wildfire relief.

The AFBF Foundation for Agriculture creates agriculturally literate citizens through educational programs, grants, scholarships, classroom curriculum and volunteer training. Maryland Farm Bureau members use resources from the Foundation like free games and lesson plans to educate elementary school children.
