## #8: March 12, 2021

Welcome to Hotline 8. This week was filled with subcommittee and full committee voting sessions and a few days of lengthy bill hearings. Many of the Sunday hunting Senate bills were finally heard. Maryland Farm Bureau advocated for the Association Health Care plans and asked to be included in them while spending many hours following committee discussions and votes. Due to bill crossover deadline being March 22nd, this will be the last weekly hotline that shows next week's bill hearings as after crossover, the hearings are scheduled much more randomly and many times only a couple of days in advance. Typically, bill hearings in the opposite chamber committees are sponsor only. So MDFB will be submitting written testimony on them. Next week's Hotline will be a priority bill update. This will show where the bills we took a position on stand in this year's legislative session. The following bills will be heard next week:

### Tuesday, March 16, 2021

**HB 639:** Tri-County Council for Southern Maryland – Property Management – Southern Maryland Regional Agricultural Center  
*Delegate Davis, E&T at 1:30 PM in 250 HOB*

This bill authorizes the Tri-County Council for Southern Maryland to act as a property manager of the Southern Maryland Regional Agricultural Center (RAC) that is being built in cooperation with St. Mary's County for the benefit of all Southern Maryland agricultural

producers.

This bill is a technical correction to allow the Tri-County Council and SMADC to partner with St. Mary's County on this valuable project and allow SMADC to manage the property.

## MARYLAND FARM BUREAU SUPPORTS HB 639

**SB 727:** Maryland Healthy Working Families Act – Revisions and Public Health Emergency Leave

*Senator Feldman, FIN at 1:00 PM in 3 East Miller*

This bill repeals the exemptions from the Maryland Healthy Working Families Act for several employee categories, including agriculture workers. The bill requires employers to allow employees to use earned sick and safe leave during a public health emergency and requires employers to provide employees earned sick and safe leave on the date that a public health emergency was declared or proclaimed for a jurisdiction. The bill requires an employer to provide earned sick and safe leave regardless of the employee's length of employment with the employer.

During the paid sick leave bill discussion several years ago, agriculture workers were exempted from this legislation do to the extreme difficulties a farm would have when trying to administer it. Unfortunately, this bill seeks to remove that exemption and add farms back into this discussion.

Maryland Farm Bureau requests the agriculture worker exemption remain in place.

### **USDA Announces Availability of an Additional \$35 Million for the Value-Added Producer Grant Program to Support COVID-19 Relief Efforts**

The United States Department of Agriculture (USDA) today announced that it is making an additional \$35 million available this year in the Value-Added Producer Grant Program to support agricultural producers affected by the COVID-19 pandemic. ### **March 15 Deadline to Complete Election & Enrollment for 2021 Agriculture Risk Coverage, Price Loss Coverage Programs**

Agricultural producers in Maryland who have not yet elected and enrolled in the Agriculture Risk Coverage (ARC) or Price Loss Coverage (PLC) programs for 2021 have until March 15. Producers who have not signed a contract or who want to make an election change should contact their local U.S. Department of Agriculture (USDA) Service Center to make an appointment.
