- Scholarships are open to any graduate or graduating high school senior that has been accepted to an accredited institution as an undergraduate or who is currently enrolled in post-graduate courses.
- Applicant **MUST** be a resident of Cecil County.
- Chester County, PA. Farm Bureau Board Members will serve as the Selection Committee.

RAY MUELLER SCHOLARSHIP

- Scholarships will be awarded on a combination of need, high school grades, extra curricular activities and community involvement.
- **Applicant MUST be a son or daughter of a Farm Bureau member.**
- Applicant **MUST be in an agriculturally-related** course of study.

STEVE CARSON YOUNG FARMERS SCHOLARSHIP

- Scholarships will be awarded primarily on the basis of farm or 4-H experience.
- Need, high school grades, and extra curricular activities may serve as secondary selection criteria to separate similarly qualified applicants.
- **Applicant MUST be a son or daughter of a Farm Bureau member.**
- Applicant **may pursue any discipline.**
